If such charter is surrendered to, taken away, or revoked by CSEA, this corporation shall thereupon dissolve. If this corporation is dissolved for such reason or of any other reason or cause whatsoever, all of its assets, after compliance with the applicable provisions of Chapters 15, 16 and 17 of the California Non-Profit Mutual Benefit Corporation Law, shall be distributed to CSEA. The foregoing provisions may not be amended without the written consent of CSEA.

RE: Assignment of Rights Under Affiliation Agreement With SEIU

Dear Mr. Hard:

Pursuant to Article IX, section 1 of CSEA's Bylaws and Article 6 of the Affiliation Agreement with the Service Employees' International Union ("SEIU"), on behalf of the California State Employees' Association, CSEA hereby assigns all of its rights, powers, duties and obligations under the Affiliation Agreement as pertains to the Civil Service Division to the Union of California State Workers, known as "Service Employees' International Union, Local 1000 (Union of California State Workers)" or "SEIU Local 1000 (UCSW)."

This assignment is effective immediately and shall continue in effect as long as SEIU Local 1000 (UCSW) remains an affiliate of CSEA under its bylaws. Should SEIU Local 1000 (UCSW) cease to be an affiliate of CSEA, CSEA's rights, powers, duties and obligations under the Affiliation Agreement as well as the Agreement itself shall automatically revert to CSEA.
